#### WILLAND ROVERS FOOTBALL CLUB

Rovers started another Western league campaign after finishing a credible 6th in the league. In the summer Russell Jee and David Steele have worked tirelessly to recruit some quality players. Having managed to secure last season's back 5, the job in hand was to try and find a midfield combination that could score and create goals, plus strikers who could find the back of the net with regularity.

Brett Worbey and Luke Alden have been joined in midfield by Glenn Gould Luke Mortimore and Josh Searle. Gould has fitted in seamlessly showing great energy and revelling in holding the midfield role. Mortimore has started the season brilliantly with a number of assists and 12 goals to boot. Searle has shown his versatility by playing in 4 positions already. All three are making a difference.

Up front a new combination of James Blake and Brad Ausden has shown early promise. The returning Blake has added to his 50 Willand goals with another 10 already this season and Ausden playing at this level for the first time has slotted in 5.

Due to the quirks of the fixture list the first game of the season was an FA cup match where we travelled to Cheddar, a Blake double put us through to play last year's Western League Champions Bristol Manor Farm, Ausden put us ahead with a fantastic strike after 5 minutes and although BMF equalised, Mortimore popped up in injury time to put Willand through. A trip to Wales

ensued but we were soundly beaten by a club 2 leagues higher playing on a plastic pitch.

In the league a first home game defeat then lead to an unbeaten 9 game league run which ended last Saturday with a narrow loss. The club now concentrates on the FA Vase when we entertain Street in what is the tie of the round for the West Country.

The charity team Braveheart's have joined the Willand family and play at Silver Street on Saturday's and Sunday's. The team was formed by a group of lads in memory of Cullompton resident Daniel Coffey who was killed whilst serving his County in Iraq.

As Willand and the surrounding area grows, the club are looking for ways to improve and are considering a ground swap move to a new purpose built, 2 pitch facility so watch this space for interesting times ahead.

#### **WILLAND PARISH COUNCIL**

Your Parish Council has been involved with or initiated a number actions within the village – some more successful than others. Sadly, one of our councillors has chosen to leave us and so we are now down to nine. There are two vacancies if anyone feels that they can give some time please do, help try and make the community we live in a better place.

The Community Payback teams have been back in the village and cleared some footpaths and areas which Devon County Council [DCC] are responsible for but under their Tough Choices programme no longer maintain. The feedback we receive shows that the work they do is appreciated. Our thanks to Labdon Building Supplies, Cullompton for giving us dumpy bags to put the rubbish in, Andrew James Butchery at Four Cross Way for subsidising hot drinks for the workers and to our Community Composting Volunteers for making the site available to take the cuttings. Hopefully DCC will pay the expenses of the Community Payback scheme as they did last year.

DCC have done their last cut of the year of the visibility splays on the verges. The Parish Council – in other words you the parishioners – paid for a contractor to cut all the areas they left behind and had not touched all year and that was the subject of favourable comment from several residents. The contractors will be coming back before the end of the year to give all the areas a really good cut back. It may have already been done by the time you read this.

The Parish Council has decided that it will take on the grass cutting of these DCC verges next year and have put the work out to tender. The details are on the Willand Matters Website. Some monies will be available from DCC but the bulk will have to come from our precept and so there will be a rise in the parish part of your council tax. The contract will require at least 10 cuts per year which it is hoped will keep it looking tidy but some areas where there are wide verges or banks will be left until the end of the year to allow the wild flowers to grow and hopefully maintain a good insect population. Those areas will only be cut back at the end of the year. Just a metre strip at the road edge will be cut regularly. We do hope to avoid the untidy look of loads of grass left in heaps on the verges as it will be evenly spread around. This work will not cover the areas which are the responsibility of Mid Devon District Council [MDDC]. If you are looking after a section of verge yourself the contractors will give it a miss and leave it to you but we have it covered if you should move or no longer be able to look after that bit. Many thanks to all those of you who are doing your bit and also to those who have responded positively to requests to cut back hedges or shrubs when asked - or better still before it is necessary to ask. One or two have had formal letters from DCC to clear back growth affecting pavements and we would prefer that that did not have to happen.

Weed spraying of the kerb edges has again been carried out and Councillor Ray Radford [DCC] has funded half of the cost of this from his Community Fund, thank you Ray.

You will have seen from the press that MDDC appear to be overseeing a managed decline of some play areas and will not always replace equipment as it becomes unserviceable. The Parish already look after three areas and it is now about to take on a lease for 25 years for the South View Close play area to protect it. MDDC have done some works to bring the fencing up to standard before it is taken on. Any residents in the Close who can help with cutting the

grass and keeping a watchful eye on the area are asked to contact the Clerk. This scheme is working quite well elsewhere.

The Parish Council are now looking at taking on the Orchard Way play area as we feel that it could be improved by having the grass cut more regularly and from having some more 'challenging' equipment in it particularly for the older children and teenagers. It needs a new fence against Orchard Way pavement before we go that far but watch this space. If you have any views please send them to the Clerk or talk to one of the Councillors. Incidentally some thoughtless souls have cost the parish money by causing damage to certain items of play equipment. Please tell us who it is so that they can pay for it to be put right rather than all of us having to share the burden of their selfishness and stupidity.

Planning continues to be a concern and the further delay in the Local Plan Review basically to allow MDDC to have another go at getting things right around including Junction 27 land is putting us further in jeopardy from speculative applications from developers. Another 30 houses have been agreed to on appeal to add to the 60 along the Uffculme Straight. Your Parish Council was represented at an appeal hearing against the 259 houses between the woods at the edge of the village and the Esso Garage. One must guestion the commitment of MDDC in trying to defend these applications. The developer was represented by a barrister, a planning consultant, a transport consultant and two support staff. They had submitted a 395 page report to the inspector setting out their case and the failings of MDDC to have a proper plan. MDDC was represented by an Area Team Leader Planning Officer (Part Time) and a Transport Consultant from DCC Highways. MDDC had not submitted anything other than the original officer report when the application was first refused. DCC had submitted a written representation. Councillor Bob Evans one of our Ward Councillors made representations and Councillor Gillian Doe also attended in support. Sadly, Councillor Richard Chesterton, the portfolio holder for planning was not there. It was found out that two more sites amounting to a further 59 houses are being 'sat on' awaiting the outcome of this appeal. Personally, I am not holding my breath and so we could see Willand with an increase in housing and population of 21% over the next five years. With little or no infrastructure to benefit the village or to keep our community as a community.

Some who follow geography will realise that when they built the M5 a lump of Halberton Parish became isolated and could only be got to via Willand or Sampford Peverell and Burlescombe parishes. Part of Halberton is in the Willand settlement Area and planning applications made in that area do not result in Willand or Uffculme being consulted. In 2002 Willand and Uffculme Parish Councils suggested to MDDC that this area be divided between them. MDDC delayed it to 'wait and see'. Both Parishes in effect have expanded with development in Halberton area but they have seen no benefit from it. Nothing happened and so in 2014 we had another go and the then MDDC Chief Executive decided to put it off until after the District Council Elections. Nothing happened and so we asked again and then an officer said it should wait until

after the County Council elections. Then there was the General Election. We have asked again and the Chief Executive has said a boundary review will be done but it will not happen in time for the 2019 elections and so it will be 2023 before anything happens. He has given a very firm assurance that this is an undertaking from him that a review will happen – not that the boundary will change. Being a realist, I doubt if I will still be around in 2023 and I would not be surprised to find that the Chief Executive will have moved on to better things by then. Foolish boy – I thought that we elected Councillors to make decisions!!

Some residents have expressed concerns as to the safety of the bridge over the motorway following one death and another attempt recently. We have written to Highways England asking them to review the safety situation.

The Parish Council is working with the Village Hall Committee to install WIFI in the hall. The telephone line is in and the rest will follow shortly. It may be a bit slow at first as there is no spare capacity on the fibre cable but we are assured that it will come.

Parking around the village is becoming a joke at times and unless you want the village covered in double yellow lines those irresponsible residents around need to have a rethink please. School drop off and pick up time show some at their worst and for someone to abuse a police officer who is trying to achieve some sense out of self-imposed disorder does not help. Parking on junctions, verges and across people's driveways cannot be justified. Around the estates some are parking on the wrong side of the road at night and when the street lights go out that make this more dangerous. Parking near or right opposite junctions is contrary to the Highway Code and whereas the police do not seem to do much about it they will have to if there is an accident. I know that the planners and developers have caused problems in the past by not making roads wide enough or making proper provision for parking but at the end of the day it is each individuals responsibility to park properly and safely. YES, it does apply to you as well as everyone else.

How can I complete an article without mentioning dog mess and irresponsible owners? Some of you will have seen the entries on Facebook and we now have some firm sightings of 'offenders' and they are being watched to get firm evidence. To pick up but then throw it over the fence into someone's garden takes the biscuit! You can put your bag in normal litter bins if there is not a dog bin BUT NOT IF IT IS IN A FENCED CHILDREN'S PLAY AREA PLEASE.

If I do not get the chance to do so in a magazine before Christmas may I wish you a very Happy Christmas. That reminds me – the contractor has given us a date for putting up the Christmas Lights. #### COMPOSTING CONTINUED

**Christmas trees** accepted providing they have no decorations and the branches are no more than 1" in diameter.

**To purchase compost**: Collect from bags outside the main gate insert payment into tube located below and replace tube cover. If no bags available outside then text COMPOST to **07514 033305** and someone will contact you. Sieved Compost is £1.50 per bag and unsieved is £1.00 per wheel barrow. If you need to you may borrow the wheelbarrow from the side of the allotment shed but it must be returned. Please return any empty bags.

#### **Composting Matters**

**Leaves** - Did you know that instead of raking leaves you can mow the leaves (mower to have collector) then cover your soil (flower beds/vegetable plot) with the mowed leaves. This will add nutrients to the soil.

We only accept dry leaves at the compost site please deposit in the nominated bay - nearest to the main gate. Your cooperation is appreciated.

**Garden waste -** Please continue to only deposit that which we accept (see signage). Particularly, Grass Cuttings need to be fresh and not left to be rotted in bags/wheelie bins.

To those very few who visit us and we either comment or very rarely refuse to accept their material - please do not take offence. This is only for composting reasons. We hope that when you next visit the site it will be a good experience.

#### COUNCILLOR BOB EVANS

Following on from my initial article in June I'm hoping that a periodic note into the magazine may be of benefit to readers who have an interest in District Council issues. Can I start by asking readers if they know anybody that is considered to be Severely Mentally Impaired? (SMI) If so there may be a discount available on their council tax, it's complicated to try and script all details here but a couple of notes below may assist, my advice is if you think somebody may be entitled to a discount ask the council, they will help.

If one person lives in a property and they are SMI then they are exempt and pay nothing. (Class U exemption)

If there are two persons in the property and one person is SMI then they are entitled to 25% discount disregard and they pay 75%.

If there are two persons in the property and they are both SMI then they will pay nothing. (Class U exemption)

To explain the entitlement I have quoted Council tax Law and Practice, which explains the criteria as follows:

"A person is disregarded for discount purposes if he or she is severely mentally impaired and is stated to be such in a certificate from a registered Medical Practitioner, provided that there is entitlement to a state benefit from the qualifying list of benefits or other specified requirements are met. Schedule 1 of the 1992 Act provides the definition of SMI as:

A person is Severely Mentally Impaired if he has a severe impairment of intelligence and social functioning (However caused) which appears to be permanent.

The qualifying benefits are contained in the application form on the Mid Devon Website or simply phone the council and ask.

### Other current issues in brief..... Planning

Is always a talking point and I along with many councillors get many comments and questions. Unfortunately much is based on rumour but given the time many applications take that's unsurprising. Here are some known local applications:

#### 17/00652/MOUT

ESSO garage. Mix of 30 residential properties and commercial units. This is still awaiting a decision. I note it has over 70 objections, that's very high and is certainly a factor noted by officers.

#### 17/01179/FULL

29 residential properties in Silver Street. This is still awaiting a decision. I have attended meetings on this application and currently object given it's on a site that is only a backup set against land that is in the emerging local plan and agreed for development.

#### 17/00300/MOUT

Not truly Willand but very close along The Uffculme straight, application is on the same site as 60 houses agreed by an inspector after an appeal by the developer. The application had been refused by MDDC but I have been informed this has also been granted following appeal.

#### <u>16/01811</u>/MOUT

259 houses mixed sizes. Again this has been refused as it's on land outside the local plan, I attended the full day appeal hearing on 3rd October and await the inspectors decision as I type, however this may be know come the magazines publication date.

Any of the above can be accessed via the MDDC planning portal, if you put the numbers in the full details with all documents will be available.

Final note on planning. The agreed Co-op store (to be built on the Mid Devon Business Park) has been an interesting case. Some may recall that when this originally went to committee I had a condition attached for a zebra crossing to

be installed. The Co-op have twice attempted to remove this condition, I'm happy to report that following much email correspondence a meeting was held on 11th September with representatives from the Co-op, Devon County Council, Willand Parish Council and myself, where provision of the condition was discussed. The Co-op have agreed that they will be providing a crossing facility in South View Road allowing safe access for all. My thanks to the Parish Council for their support on this issue.

The Public Examination of the Local Plan Review was due to commence on the 26th/27th September with the Inspector looking specifically at the allocation of land at J27 ( Eden Westwood) and associated housing. Unfortunately MDDC have requested a delay in the examination following legal advice, this will not only delay the examination of the J27 elements but also the plan as a whole, leaving the district vulnerable to further unplanned and speculative planning applications. My position is well documented given the overwhelming responses I have received against the proposals, please watch local press and MDDC web pages as I believe following additional work a further opportunity to comment will be available as further consultation will now be necessary.

Play parks. To cut the narrative short I sit on the Environment Policy Development Group and have been involved in the debate on play park fencing. I am looking to get an agreement to set a new policy that requires MDDC and all Developers to comply with aspects of a report published by 'Play England'. This outlines design ideas, specifications and maintenance of play areas and open spaces. An excellent document and worth a read. If I get the policy through to Full Council and agreed this document would become the guide for all future play parks in our area.

**Audit Committee.** As Chair of Audit I am delighted to report that for the second year running MDDC were able to submit the full set of accounts to Central Government on the very first day of account filing period. This is a fantastic achievement by our Officers who have worked hard along with our audit partners, Grant Thornton.

**Economy PDG**. Our last meeting saw discussion on some very exciting projects that would not only bring benefits to local residents but also local businesses. These are both challenging and exciting times as councils up and down the country try to fill funding gaps.

#### Whole School Activities

Recently, we were celebrating European Language Day. Each class was given a different country to learn about. The children dressed up in the colours of their flag and traditional costumes. In addition, they all learned a bit about their country and presented it in assembly.

#### Eco

#### AMNESTY INTERNATIONAL

UK Lawyer Peter Berenson founded AI in 1961. He had read that two Portuguese students had been imprisoned for 7 years for raising a toast to freedom. His original idea was that a network of letter-writers could bombard governments with individual appeals on behalf of prisoners of conscience who had been jailed or ill-treated, in violation of the Universal Declaration of Human Rights (UDHR).

The UDHR was adopted on 10.12.48 and of its 30 comprehensive Articles the two most important ones form the basis of Amnesty International's work. Article 18 – Everyone has the right to freedom of thought, conscience and religion...."

And Article 19 - Everyone has the right to freedom of opinion and expression...."

Amnesty took as its symbol a candle in barbed wire, because "It is better to light a candle than to curse the darkness". All now has over 7 million members and supporters world-wide, and is the largest human rights organisation. All received the Nobel Peace Prize in 1977.

Amnesty Internationals work has expanded since 1961. It retains its original focus on Prisoners of Conscience, but now includes support for human rights defenders and people at risk; campaigns to oppose the death penalty and torture; support for refugees, migrants; rights of women, children, LGBT, disabled people; international justice; censorship and free speech.

#### Results

- Al has been instrumental in the creation of nearly 1100 Human Rights Treaties and other legal instruments for example the UK Human Rights Act 1998. Without the UK Human Rights Act there would have been no inquest into the Hillsborough Disaster of 1989.
- 2) Recently 3 human rights defenders were released in the Sudan, Albert Woodfox from the USA was released in Feb 2016 after 43 years in solitary confinement and said "I cannot emphasise enough how important letters from people around the world was. It gave me strength, made me more determined. But more than that, it gave me a sense of self worth..."
- 3) Former Prisoner of Conscience Ihar Tsikhan of Belarus said "When I feel left with no hope to fight I'll get a letter and it inspires me. The light of hope appears again and my confidence in myself and my ability to change things returns. I thank everyone for their solidarity and letters". He is now released.
