We learned about the history of this historic house in the centre of the town and how it was rebuilt following a devastating fire in 1602. It has a very chequered history changing hands many times over the years. When work was undertaken restoring the overgrown garden Roman pottery was found including a complete amphora. This came presumably from the old Roman fort in the vicinity of the now Shortlands estate. The house was near derelict and restoration was a massive task and finally, when all the funding was in place which took years of complicated negotiations, work began on the house. The Trust managed to employ local skilled tradesmen and women bringing welcome work into the town. The slides showed the amazing work that has been carried out. Tenants live in part of the house which brings in much-needed funds. Lots of local groups hold meetings and functions there from coffee mornings to birthday parties. Visitors come from far and wide to view the house and gardens and the years of dedicated work from volunteers has saved an historic building for the benefit of the town and surrounding area.

November 11th dawned and with it a typical dank and drizzly morning and we were a little bit concerned that we would not welcome many visitors to our Xmas Coffee Morning in aid of Devon Air Ambulance. However we need not have worried as our faithful supporters turned up as they always do, we couldn't run these events without their support! As this was Remembrance Weekend we had two minutes silence before we officially opened. We would like to thank Tescos for giving us all the mince pies and an anonymous donor for kindly donating the pasties and sausage rolls, this was much appreciated. We had a large variety of stalls some manned by Cameo members and some from other organisations in the Village and we are pleased to report that we had made a profit of just over £1,000 and counting! WILLAND HEALTH AND COMMUNITY CENTRE

We would mention that over the last couple of months there has been a short set back concerning the lease, which has been amended by the Parish council to include further clause additions and alterations that require the attention of the WH&CC solicitor. This is not seen as a major issue, but it does add further cost, time and delay to the finalising of the lease, which the trustees are keen to see legally completed.

Progress continues to be maintained with the selection of a shortlist of three architects to be considered for the design and development of the project. A

"due-diligence ", programme has been determined to ensure the final architect will have the design capability and experience and awareness to work as part of a team with the trustees to bring the centre to completion. It is hoped to make the final selection early in the New Year.

A comprehensive draft Feasibility Study has been undertaken to validate exactly what the residents of Willand want their Health & Community Centre to be, and what facilities they would expect from this major investment project. A short survey/questionnaire is currently being prepared asking informative questions that relate to the final acceptance of the final facilities and services the centre will deliver. Hopefully the questionnaire will be pushed through your letter box sometime during January 2018, please take time to complete this short survey, as the analysis will be included in the Feasibility Study, which will be used to promote future funding applications.

The WH&CC has reached the stage where it needs to attract other trustees with more professional support backgrounds, particularly with some experience in Accountancy, Legal, Medical, Marketing and perhaps with retail knowledge. If you could give about three hours a month it would add so much to the work being currently undertaken by the trustees, and help in making decisions that will shape the future development of your village Community Centre.

UP DATE FROM DISTRICT COUNCILLOR BOB EVANS

I hope all who read this enjoy the festive season and get to spend some precious time with family and friends, let's hope that 2018 will bring to an end the uncertainty that MDDC continues to endure over planning issues that are increasingly affecting more and more communities.

On the subject of planning a small victory can be reported in the defence of the application for some 259 houses, the inspector ruled that the application was simply too large for Willand and so refused the appeal, unfortunately he didn't

rule on the issues on highways that we had hoped and so I'm afraid we can expect a new application albeit smaller in scale in the coming weeks, watch the planning portal.

As a result of the inspectors ruling we face a real difficulty in defence of the application for 30 houses adjacent to the current Esso garage, application 17/00652 and have an officer recommendation to grant permission on this site, in truth I see little we can defend this on given the inspectors comments and continued lack of an up to date local plan and lack of 5 year land supply.

To add to concerns as I write I have a meeting this pm with the head of planning and other ward members to discuss application 17/01179 an application for 28 affordable houses off Silver Street, my issue here isn't we don't want affordable houses we do, my issue is given the number of affordable houses that will be in the 30 above (should be 11) the further 14 that will come from the 42 already in the emerging plan the 7 already built in Ash close, Willand will be over supplied with affordable houses and so if all agreed will simply add to the infrastructure issues on highways, schools etc without the supply of additional infrastructure needed to cope.

With all things there is a balance needed and building on this scale should be planned, as stated previously these are speculative applications so are not part of an organised and cohesive plan, many are simply cash cows for developers looking to take advantage of MDDC's situation at the expense of local communities.

Please remember your voice counts so please if you have comments/concerns, please, please send in your comments on any planning applications via the MDDC planning portal.

Let's hope next year we can comment on other issues and not just more planning applications.

CRIME IN WILLAND - Is on the increase?

You can keep up with some of what is happening by looking at WOW-What's on Willand on Facebook. There have been attempted break ins, burglaries and the theft of a catalytic converter reported.

Spearings have been targeted by thieves on several occasions and suffered yet another significant theft on Saturday 9th September 2017 and when speaking to the police, they suggested trying to make it public knowledge for community support, witnesses etc. This was published on face book and Willand Matters.

The incident is outlined below to give you an idea of the thefts that they are having:

The incident happened in the early hours of Saturday morning 9th September. coach batteries were stolen and significant damage caused to 4 coaches parked in the layby opposite the Halfway House, Willand. An attempted theft was made on a 5th coach where they caused substantial damage to the coach in attempt to steal those batteries. 8 commercial batteries were stolen in total, as well as sets of commercial jump leads, emergency hammers and tool boxes were stolen. There was severe damage to the battery caging on 4 vehicles, all the wiring was ripped out, severe damage to a locker panel, where it was ripped off the vehicle, a lock was broken and an indicator light broken. This subsequently put these vehicles off the road for use. Spearings are a small family run business and this continual amount of damage and theft is extremely damaging to them. The company have always been hit hard with fuel theft but the damage to acquire the fuel and the tools is becoming increasingly worse causing significant damage and putting vehicles off the road. Please keep your eyes and ears open and if you notice anything suspicious call the police.

"PROSPECTS" - is a group in which learning disabled people can joyfully meet together for Christian worship and fellowship through music, drama, song, arts and craft activities.

The nearest one to you is held at Culm Valley Methodist Church, Gables Road, Willand on alternate months. WILLAND PARISH COUNCIL CHAIR - COMMENT & REPORT

"What's going on?" I keep hearing these words on a particular TV advert and they are beginning to annoy me. Now I find myself using them in relation to some issues surrounding Mid Devon District Council Planning policies and performance.

The Government Inspector dismissed the appeal against the 259 houses between the woods and the Esso Garage mainly on the grounds of scale as it would have too big an adverse impact on the village. Do not cheer too quickly as I would be surprised if they do not come back with another application for a smaller number and then again for another number until the whole area is filled in. Watch this space and tell an old cynic he is wrong.

MDDC have just approved a further 28 affordable houses for rent to be built next to Ash Close. They have not even imposed their own policy in relation to

the improvement of the footpaths to the village which are needed to ensure the safety of residents, particularly children, going to and from the school and other facilities. The committee were even shown the wrong layout plan and figures as to housing need were flawed but that did not matter to some. The suggestion that the 40mph be reduced to 30mph was discounted as Devon County Council Highways had not raised it and it was said the Parish Council could raise that issue with DCC. We can if you are all prepared to put up the £3,000 needed to achieve an order. At least DCH, who will manage the houses', have offered to work with us to try and resolve that issue. Bob Evans speaking as a Ward Councillor argued the case for deferring the decision until certain matters were resolved and Richard Chesterton had written in supporting Bob. He was supported by Jill Doe and Ray Radford as members of the committee. They were outvoted although they had support from Councillor Christine Collis.

We now have to await the decision for the demolition of the Esso Garage and the building of 30 houses and some retail space on that site. Set for Planning Committee on 3 January 2018 when most will have been on holiday so will not be able to check all the paperwork. In the past there should have been retail units in Gable Lea and Meadow Park as part of the developments but where are they? MDDC Planners let developers build houses on the site.

Little or none of this would be happening if we did not have the delay over the local plan to accommodate the development at Junction 27. We are not alone as other areas are getting applications to build on sites which are not planned for. You know the one where they are building a retail park to solve the town centre problems of all the empty shops in Tiverton, Cullompton and Crediton! I have been asking questions about the cost of this delay and some figures have been given but in the main I am told that they will not disclose the figures as it may be used to mislead. Well I have found that it has cost at least £113,000 to date for consultants and reports and we still do not know the cost of the barrister and the latest consultant work. I asked to see the barristers' advice that requires the further delay and consultant work. That I am told is privileged information – why? I suppose it could show us that the job had not been done properly before the plan, including J27, went to the Inspector.

Like I said - What's going on?

If Willand residents do not start taking more interest, asking similar questions and banging the table we will have more and more houses with no infrastructure improvement and primary school aged children are likely to be refused places at Willand and have to go elsewhere – not my words, before I am accused of scaremongering, but a response from DCC Education in respect of a further planning application for more houses.

Bob Evans has been particularly active in trying to help with planning issues in Lower Culm Ward – Uffculme and Willand – and he will no doubt offer his own take on things.

What has been going on in Willand? The Christmas lights should be up and our thanks go out to those companies and organisations which have made donations towards the cost. I am sure our Clerk will make sure the detail of their generosity is appropriately recognised. This is the last year of the current contract and so what do we do next year? With other demands on the precept do we continue funding the Christmas lights with some helpful contributions as we do now? Is there a group who would like to take on the project from the Parish Council and fund raise? Do we not bother with Christmas lights anymore? Please let the Clerk know your views. I will admit to being a 'Bah Humbug' when it comes to Christmas so speak up if you want them. It is sad that we do not have a village centre to use as a focal point.

Contractors have done a final cut of all the DCC grass verges in the parish and the cost has come from our reserves. We have received a number of favourable comments as to the fact that the village was beginning to look tidy again. Any areas where the grass looks longer are MDDC responsibility areas. The Parish Council has awarded a one year contract to Halcyon Landscapes to cut these verges at least 10 times during 2018 and so we hope that the village will look better than it has for the past couple of years. They come very well recommended by a number of parish councils in Devon and Somerset. Countrywide will still be looking after the Jubilee Parish Field and did an excellent job on the final cut of the verges but their price for the verges was not as competitive as Halcyon. At the end of the day we have to try and achieve value for your money but we are not putting all our eggs in one basket. We are already chasing DCC for their contribution towards the cost of next years cuts.

The Old Well Garden Centre has again given us a generous discount on the plants for the planters around the village. Thanks are also due to John Holmes and the other volunteers for keeping them tidy and planting up the new plants. The handyman has also been around and replaced the supports which hold the boards in place.

The Parish Council now has the lease for South View Close play area but sadly none of the local residents has volunteered to cut the grass so that will have to go to contract as will Mallow Court. Orchard Way play area still awaits a response from MDDC at the time of writing as to whether or not they will replace the chain link fence. We have looked at meeting a request for a further notice board in the Willand Moor Road area but the response was very low and so a decision has been deferred for a year but in

the interim details of agenda, minutes and other information is available on the website.

NEWS FROM AMNESTY INTERNATIONAL MID DEVON GROUP

We are not sure when the magazine will be distributed so we hope you all will have – or have had - a lovely Christmas, and we wish you a very Happy New Year 2018! Gosh, how time flies....

Our news for the Willand Magazine refers to the last few month's activities of 2017 when our group met every first Thursday of the month at Halberton Methodist Church to focus on letter writing to our 'prisoners of conscience'. They are given that title by Amnesty because they have either written or expressed a *non-violent* opinion that has annoyed the governments of countries in which they live. Our current prisoners are Dr Mordechai Vanunu, an Israeli; Raif Badawi and his lawyer Waleed Abu al-Khair who are Saudi Arabians;

Eskinder Nega, an Ethiopian; and Nazanin Ratcliffe, a British/Iranian. Sadly Nazanin has been in the news a lot recently because of ill-advised comments from Foreign Secretary Boris Johnson....We also wrote to the Chinese Nobel prize-winning poet and writer Liu Xiao-Bo, but regrettably he died of cancer while in prison.

Alongside supporting these people we also took part in writing 'Urgent Actions' where we had been informed by Amnesty that lives were in immediate danger. For instance, in Turkey, Amnesty officials and activists were recently arrested in a crack-down by the Government. While some of them have been released pending trial, they are among thousands of Turkish civilians who are still in prison, including members of the judiciary, military personnel, academics, journalists, teachers etc etc.

On a happier note, we held our annual fund-raising concert on Friday 13th October at Willand Church Hall. As usual, the occasion was a sell-out and we raised the grand total of £840. Many folk around here came to support us and we heard musicians, poets and had a good old sing-a-long. There was a generous raffle, with prizes donated by local businesses, lots of food, and a good time was had by all!

We have also had regular monthly attendance at Uffculme Farmer's Market where we sell our books to raise crucial funds to pay for postage. The good folk there are always interested in what we are doing and support us when there are letters to government officials or prisoners to sign. At the time of writing this article, we have the happy prospect of looking forward to enjoying mulled wine and mince-pies at a member's house while writing cards to people all over the world – the event is called 'Write for Rights'. Next comes a Christmas 'social' at Chris and Alan's where we eat, drink and have fun!

Finally, we would like to take this opportunity to thank EVERYONE in this village who supported us at events we have organised during the last 12 months. CULM VOLUNTARY CAR SCHEME (CVCS)

CVCS is a community car service for frail, elderly and disabled people in Cullompton and surrounding areas, mainly including Willand, Uffculme, Kentisbeare and Bradninch. Transport is provided by our volunteer drivers, using their own cars. Priority is given to taking people to hospitals, doctors' surgeries, dentists, opticians and other health appointments, but we also take people to day centres and some social trips. We have volunteer coordinators, who work from their own homes on a rota basis, and cover about one week per month taking phone calls from the passengers, Monday to Friday 9.am to 1.00pm. They record information, arrange a driver, and then confirm details to the passenger. Due to ill health we have lost some of our

co-ordinators over the past few months, so we are now looking for volunteers to become co-ordinators.

THE CULM VOLUNTARY CAR SCHEME require volunteers to take telephone calls in their own home, on a rota basis with other volunteer coordinators, weekday mornings approximately one week per month. You would arrange for our volunteer drivers to take elderly & disabled people from Cullompton & surrounding areas to appointments at hospitals, surgeries etc. Yu would be providing an essential service in the community and get to speak to some interesting people at the same time. WILLAND HISTORY GROUP

Happy Christmas from everyone at Willand History Group, and we wish you all the very best for the New Year!

A recent survey of old newspapers has given us a few snapshots of Willand's Christmases past. Almost 150 years ago, in 1868, the wealthier members of Victorian society made charitable donations to the local poor at Christmas, as was the custom. For example, Mrs Quant, wife of local businessman John Quant (Tiverton Junction), gave tea and sugar to each poor person in Willand.

Similarly, JW Walrond Esq of Bradfield House presented 5 hundredweight (255 kilograms) of coal to over 100 poor families in the parishes of Willand and Uffclume – while Mrs Walrond formed a blanket society, supplying one or two blankets to each poor family. On Boxing Day 1868 Revd Sydenham, rector of St Mary's Church, showed his 'seasonable benevolence' by providing, "a substantial dinner of beef and mutton with a quart of ale ... to every poor man [and woman?] in the parish of Willand." The report in the *Tiverton Gazette* adds cheerily that, "it is a remarkable circumstance that during the year not a single adult has died in the parish, the only two funerals being those of infants." The surviving children of Willand enjoyed their festive treat in early January, when the 61 pupils of the National School were, "regaled with tea and plum pudding, by the rector and his lady, after which a Christmas tree, with other amusements."

Fast forward a century, on Wednesday 12 December 1956, Willand Over 60s Club held their Christmas Party at Willand Primary School. After tea there were games arranged by Mrs F Vile and Mrs T Hawker, with gifts provided by Mrs G Vile, Mr G Godfrey, Miss N Pope and Willand Methodist Church Guild. Mrs OH Little and Mrs Vinnicombe played the piano and members of the Over 60s Club committee presented a sketch called 'Uncle Tom Cobley'. Thanks was then given to Mr G Shore who had donated logs which had been distributed to all the Over 60s Club members. It was clearly a busy time in the village social calendar, as the following evening, Thursday 13 December 1956, Willand Garden Produce Association held their annual do, also at the Primary School. Their president, Mr CW Baker, welcomed guests; entertainments were organised by Miss J Vickery and Mrs CJ Parish; refreshments by Mrs J Fewings and Mrs G Chinn; and Mrs OH Little was at the piano again.

Of course, tragedy could happen over the festive period just as it could at any other time. Christmas 1939 must have been particularly tense, being the first of the Second World War. This was during the period known as the 'Phoney War' before major military operations had begun, but when the country was hurriedly gearing up for what was expected to be a long and costly war: national defences were being bolstered, young men were being conscripted and food rationing was introduced. Even down in Willand blackout restrictions were being strictly enforced to prevent enemy aircraft gaining assistance from lights on the ground at night. This included placing a 'mask' over vehicle headlights to deflect the beam downwards - night time driving became difficult and perhaps unsurprisingly there was an increase in road traffic accidents. On the evening of 31 December 1939 a motorist was driving his car carefully at 25mph along the 'main road' to the north the Halfway House, with headlights appropriately masked. At the same time Private Harold Cross (from Ashill), a 20 year old soldier in the 4th Devons, and his lady friend, Miss Barbara Joyce Jarrett (South View, Willand), were walking side by side further up the road. The driver of the car noticed a lorry approaching on the other side of the road. He slowed down, but because his headlights were so restricted he still did not see the two pedestrians in the darkness until it was too late. He hit the brakes, but struck Harold Cross, who had been walking on the outside. Despite the best efforts of medical staff at Tiverton Hospital, the young soldier died two days later. The driver of the car was exonerated at the inquest and a verdict of accidental death was recorded. James Morrison, 01884 250057 (jamorrison235@gmail.com)

A MESSAGE FROM THE PARISH CLERK

As I am sitting down to put together my third annual budget for the parish council I am amazed at the variety of issues that have come up during the two and a half years I have been the parish clerk, and the new challenges the Council faces as County and District funds are reduced. Having lived in Willand since 1991 I am ashamed to say I was too busy with my full time job and my family to take any notice of what was going on around the village — apart from feeling free to moan about the development taking place and other things that came to my attention as I rushed on with my own activities. In my defence I don't think I ever blamed the Parish Council — but this was because I was not really aware of them as a public body.

I am surprised at how long some things take to resolve – a case in point being the lease with the Trustees for the Gables site. I know there are two sides to every story, but from my perspective I sent off a lease to the Trustees in the summer of 2016, and since then the Parish Council have been waiting for them to respond with clear indications of what they feel needs to be changed in order for them to sign it. The Council cannot just hand over a public asset without safeguards, and I would be reluctant to advise them to do this. When I started this job the Parish Council were very involved in the project but the Trustees wished to separate from the Council and maybe this is what has caused the delay. To get back to the budget – this year there will be more money required for cutting the grass and maintaining play areas but the Councillors will be doing their best to ensure they can get the best value for you. The budget will be approved by the Council in January in order for MDDC to put together the council tax by April, and as usual it will be published for you all to see in the next edition of the magazine.

I am now slightly ashamed of the way I sat back and allowed a dedicated team of volunteers to meet regularly and try to impact and protect the way that the village developed. Please don't be like me – there are 3 spaces for Parish Councillors, if you care about where you live please consider standing – there are people who have been involved for years and would like to take a less active role but won't leave their colleagues in the lurch.

Have a very happy Christmas and New Year and I look forward to seeing you in 2018, if not at the parish council meetings then at the Annual Parish Meeting on Friday 23rd March. Kate Taylor Parish Clerk

CHRISTMAS TIME FOR PETS

Cats are often more fascinated by Christmas trees than us and like to climb and explore. Make sure your tree is very secure and any glass tree decorations or those with sharp edges are well out of the way of your intrigued feline. Cats also tend to eat lengths of stringy material which can then cause a concertina effect on the intestines. This can be very harmful and requires surgery to treat, so keeping tinsel and string out of harm's way is much safer! Don't forget that dogs in particular like chocolate, which can cause vomiting and diarrhoea and in larger doses, liver failure and can be fatal. The higher the cocoa content the more the risk, so keep those expensive dark chocolate truffles out of the way of any investigative hounds in the house! Be wary of chocolates on the tree and wrapped in presents within reach. Dried fruit is also a risk to dogs and can cause renal failure so keep Christmas pudding, mince pies and Christmas cake away from low tables or other places your crafty hound may be able to get to. Keep your pets safe this year.
